## **Career Opportunities**

**Programme Background:** Myanmar Red Cross Society has been implementing "Community Based Programme for Malaria Prevention" which has been funded by UNOPS/GF starting implementation in 10 townships of Southern Shan State since 2011 to 2014 and expanded to 11 townships from 2015 to 2017. This programme has been expanded its programme activities and area from year to year to such an extent that only 300 villages in 2011 to 1000 villages in 2016 and 2017. Currently this programme is extended from 2018 to 2020 with the support of UNOPS Global Fund RAI2E in 15 townships of Southern Shan State. The main programme activities in 2018 are Integrated Community Malaria Volunteer (ICMV) trainings, Community Malaria Case Management through ICMVs, Continuous LLINs distribution, Health Education Sessions, Case Detection in MMP (work sites) by Mobile Teams, etc. This programme has been closely coordinated and collaborated with National Malaria Control Programme (NMCP), State VBDC team, State Health Department, respective Township Health Departments and other stake

holders at Central, State and Townships level in implementing its programme activities and has also been contributing to achieve the Goal of National Plan for Malaria Elimination in Myanmar (2016-2030).

## Duties & Responsibilities

- 1. Planning and organizing monthly mobile team Activities in every month and detailed activities plan must be submitted to PM and Sr.PO for approval and necessary guidance
- 2. Responsible for intensified case detection in the project villages without ICMVs and mainly in mobile and migrant population including work sites
- Conduct parasitological testing to suspected malaria patients using RDTs and appropriate treatment of confirmed malaria positive cases must be given as per National Malaria treatment guideline and refer cases to nearby health centre if necessary.
- 4. Following up the treated malaria cases should be done as much as possible
- 5. Responsible for mapping and regular updating of mobile and migrant population of project townships
- 6. Regular coordinating and communicating with respective township field staffs and important stake holders at township and village level for mobile team activities
- 7. Conduct the necessary logistic management of RDT and anti-malaria drugs, LLINs, IEC materials for mobile team by coordination with PSO and LA
- 8. Give updated information about logistic supplies to PSO and LA after every mobile team visit and prepare and submit related consumption report to Sr.PO
- Regularly discuss on problems, difficulties and constraint encountered in mobile team activities with Sr.PO and PM and necessary action plan should be developed.
- 10. Submit complete Mobile Team Activities Report including technical and related trip report to Sr.PO and PM 2-3 days after every mobile team visits

- 11.Responsible for timely achieving of the target set for mobile team in LLINs Distribution, RDT testing and case findings
- 12. Give health education session, focus group discussion about malaria in targeted mobile and migrant population in every mobile team visit by using IEC materials
- 13. Supervise the work site volunteers if any in case detection and management in plantations, factory, construction sites, mines, etc. by closely coordination and collaboration with important persons of respective work sites.
- 14. Ensure safety and security of mobile team members in every visit
- 15. Make regular financial settlement of mobile team in cooperation with finance staffs.
- 16. Perform any other programme related work as instructed by Sr.PO and PM.

- Minimum 1-2 year experience in any malaria control program or any other health related program/project
- Having experience in planning, organizing the mobile activity regarding malaria and mobile migrant mapping

- Can work independently under pressure
- Can work outside the office hours, on weekends or whenever required by the program
- Must have willingness to travel to hard- to- reach/remote area
- Able to speak local language is an asset
