**Background:** Myanmar Red Cross Society (MRCS) is committed to strengthen its capacity to address humanitarian needs in the context of migration and displacement. **Purpose of the Position:** The Migration Coordinator will be responsible to manage the planning, implementation, coordination, monitoring, and reporting of all activities related to the Action Plan on Migration and Displacement.

### Duties and Responsibilities

#### 1. Implementation

- 1.1 Under the guidance and supervision of the RFL Director, manage the planning and implementation of activities related to the Action Plan in coordination with MRCS departments, Red Cross Movement partners and external stakeholders, including government departments, Civil Society Organizations, UN Agencies, and NGOs, among others.

- 1.2 Organize regular coordination meetings, information sharing and capacity building of the MRCS Migration Task Force members in collaboration with Red Cross Movement Partners.
- 1.3 Arrange and facilitate workshops, trainings, assessments, roundtable discussions, and other events related to the implementation of the Action Plan.
- 1.4 Development of tools to monitor and evaluate activities.
- 1.5 Support the identification of opportunities for further engagement of MRCS in Migration and Displacement.

## 2. Monitoring and Evaluation

- 2.1 Ensure adequate and good quality monitoring and follow-up, narrative reporting including translation, and knowledge management of documents and tools produced.
- 2.2 Conduct field visits as required and support activities implemented at the branch level.

## 3. Financial Management

- 3.1 Review and finalize budget plans and working advances requests.
- 3.2 Follow-up utilization rates regularly and ensure timely submission of working advance clearances and necessary reports.

## 4. Coordination and Collaboration

- 4.1 Coordinate with MRCS support services departments and IFRC as necessary.

## 5. Reporting

- 5.1 Preparation and submission to annual and quarterly plans of action including budgets, and monthly/ quarterly/ and annual narrative progress reports.

- 6.1 To take a higher acting responsibility as necessary.
